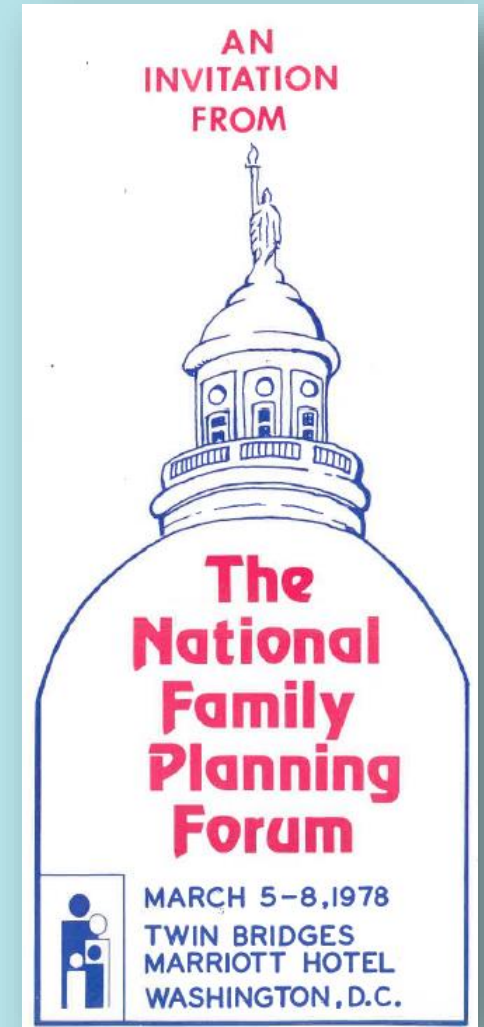

# History of NFPRHA

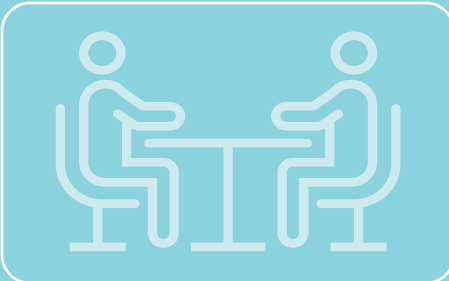
- Founded in 1971 as *The National Family Planning Forum* by a group of Title X grantees.
- Sought to unite the family planning community together under one umbrella and create an advocacy presence on Capitol Hill.
- NFPP secured funding and opened its first DC office in 1978.
- Organization renamed NFPRHA in 1979.
