Representing more than 900 members that operate or fund 3,500 health centers in the US, NFPRHA conducts and participates in research; provides educational subject matter expertise to policy makers, health care providers, and the public; and offers its members varying levels of capacity-building support aimed at maximizing their effectiveness and financial sustainability as providers of essential health care.

### FAMILY PLANNING BY THE NUMBERS

**20 million** women are **in need** of publicly funded contraceptive care.

In a given year, more than

5 million women across the
US rely on the family planning
safety net.

Publicly funded family planning services helped women avoid about **2,000,000** unintended pregnancies, which would have resulted in nearly **1,000,000** unintended births and nearly **700,000** abortions in a single year.

Services provided at publicly funded family planning visits have saved the federal and state governments a total of \$13.6 billion.

NFPRHA leverages the collaboration and integration of its program areas of Advocacy & Communications, Health Care Strategy & Analysis, and Service Delivery Improvement to address both equal access for all who need care, and to sustain the viability of the safety net.

Collects intelligence and seeks opportunities for policy allies – elected officials, career government officials, allied organizations – to protect and improve access to contraception and STD screening and treatment.



Provides information, guidance, technical assistance and support, including hands-on training, to improve operational and clinical performance to those providing these critical safety-net services.

Oversees legal action on behalf of NFPRHA members; analyzes legislation, regulation, and guidance; develops policies that support access to family planning services and providers.
