2024 National Conference Health and Safety Attendee Guidelines

Background on NFPRHA's Health and Safety Attendee Guidelines

NFPRHA recognizes that people of color, people with disabilities, and people who are immunocompromised in the United States carry a disproportionate burden of COVID; this inequity is caused by systemic racism and social and structural determinants of health. With awareness of this fact and in support of our public health system, NFPRHA is committed to holding a safe event that is inclusive of and for all attendees.

NFPRHA acknowledges that while it is not possible to prevent exposure to all environmental risks, and in particular COVID transmission, its goal is to ensure that all attendees feel safe participating in its 2024 National Conference and other in-person events. These guidelines, informed by feedback from NFPRHA meeting attendees, reflect what NFPRHA deems necessary to provide a safe and inclusive environment for its in-person event attendees. NFPRHA may change, update, or add to these requirements as it deems prudent to best protect the health and safety of attendees, and attendees must comply with relevant policies and requirements as shared by NFPRHA.

The following measures are in place for attendees at NFPRHA's 2024 National Conference:

When completing the online National Conference registration form:

- Each attendee must attest that they have received COVID vaccination(s).
- If an attendee has not received COVID vaccination(s), they must attest that they will selfadminister an at-home COVID antigen test within 72 hours of traveling to Washington, DC for the National Conference AND only travel if they receive a negative result.

When arriving onsite in the National Conference, all attendees will be required to:

- Take a COVID rapid antigen test with EventScan, NFPRHA's designated vendor that will
 be administering the tests onsite. For more details about the testing schedule, review the
 Attendee COVID Testing Schedule on page 2 of these guidelines.
- To participate in the National Conference, attendees must receive a negative COVID test result during the onsite testing with *EventScan*.
- Once an attendee has received a negative COVID test result from EventScan, then they
 may proceed to complete the onsite registration process.

Additional Expectations

Attendees will be expected to take common actions to reduce the risk of COVID transmission and to behave responsibly, including leaving the National Conference area (meeting rooms, exhibit hall, other areas), in the case of notification of an exposure to a COVID case or if they begin to experience symptoms. In such a case, attendees should seek appropriate medical attention, including a COVID test, and must immediately inform NFPRHA staff should a COVID test be positive during the conference or in the 14 days following the event.

NFPRHA also recommends, but is not requiring, that National Conference attendees:

- Regardless of vaccination status, self-administer an at-home COVID antigen test within
 72 hours of traveling to Washington, DC, AND only travel if they receive a negative result.
- Wear masks while participating in National Conference activities that are indoors.
