

# Title X: Make It Right Social Media Guidance

Now is a crucial time to shore up support for and restore the Title X family planning program as quickly and fully as possible. The Biden administration needs to take immediate regulatory action to restore the Title X network and repair the enormous damage done under the Title X rule. With 4 million people impacted by the unlawful and dangerous Title X rule and more than 1,000 health centers left without critical federal funding, we must take steps now to make it right for Title X.
