

Title X in New Mexico Improving Public Health and Saving Taxpayer Dollars

Between FY2005 – FY2015, funding for Title X was cut by \$150 million — 10% in ten fiscal years.

Title X Served 23,699 New Mexico Residents in 2015

The New Mexico Department of Health Family Planning Program is the sole Title X grantee in New Mexico, supporting 84 Title X-funded health centers across the state including federally qualified health centers, local health department service sites, and school-based health centers. The Title X network served 20,871 women and 2,828 men, for a total of 23,699 residents of New Mexico in 2015.

Title X provides high-quality family planning services and other preventive health care to low-income and uninsured individuals who may otherwise lack access to health care.

- Of the 23,699 patients served, 72% had incomes at or below 100% of the federal poverty level (FPL), iv meaning they earned \$11,770 a year or less.
- Ninety-five percent of Title X patients in New Mexico earned less than \$29,425.vi a year (250% of the FPL).vii

Title X Saves New Mexico's Taxpayer Dollars

Title X supports critical infrastructure needs that are not reimbursable under Medicaid and commercial insurance, such as staff salaries, individual patient education, community-level outreach, and public education about family planning, women's health, and sexual health issues. Without Title X, access to high-quality family planning services for low-income New Mexico residents would not be possible.

- The average cost of a Medicaid-funded birth is \$13,102.viii In 2010, births resulting from unintended pregnancies cost New Mexico's taxpayers \$239.1 million.ix
- The Title X program helps alleviate the costs of unintended pregnancy through contraception, counseling, and other services.

Title X is Essential to Improving Public Health and Saving Taxpayer Dollars in New Mexico

Cutting funding for family planning services will lead to more unintended pregnancies and higher health care costs in New Mexico. Family planning helps women and families plan the timing and spacing of their pregnancies, which results in better educational attainment and economic security; these, in turn, are linked to better health outcomes for women, men, and families.

- Family planning services at New Mexico's Title X-funded health centers helped prevent 5,500 unintended pregnancies in 2014, which would likely have resulted in 2,700 unintended births and 2,000 abortions.xi
- Without publicly funded family planning, the number of unintended pregnancies in New Mexico would be 25% higher.xii
- Title X-funded services produce significant cost savings to the federal and state governments; services provided at Title X-s

New Mexico's Title X-funded health centers provide a wide range of services:

- Pregnancy testing
- · Contraceptive services
- Pelvic exams
- Screening for cervical and breast cancer
- Screening for high blood pressure, anemia, and diabetes
- Screening for STDs and HIV/AIDS
- Infertility services
- Health education
- Referrals for other health and social services

governments; services provided at Title X-supported sites in New Mexico accounted for nearly \$65.9 million in such savings in 2010 alone.xiii

Additional cuts to Title X funding—especially in the current economy—would harm tens of thousands of low-income and poor families throughout New Mexico, in turn costing, not saving, the federal government money.
