

Title X in Alaska Improving Public Health and Saving Taxpayer Dollars

Between FY2005 – FY2015, funding for Title X was cut by \$150 million – 10% in ten fiscal years.

Title X Served 8,708 Alaska Residents in 2015

The State of Alaska Department of Health and Social Services is the sole Title X grantee in Alaska, ⁱ supporting seven Title X-funded health centers across the state including Planned Parenthoods, one local health department service site, and one private non-profit.ⁱⁱ The Title X network served 7,438 women and 1,270 men, for a total of 8,708 residents of Alaska in 2015.ⁱⁱⁱ

Title X provides high-quality family planning services and other preventive health care to low-income and uninsured individuals who may otherwise lack access to health care.

- Of the 8,708 patients served, 49% had incomes at or below 100% of the federal poverty level (FPL), iv *meaning they earned* \$14,720 a year or less. v
- Seventy-eight percent of Title X patients in Alaska earned less than \$36,800.vi a year (250% of the FPL).vii

Title X Saves Alaska's Taxpayer Dollars

Title X supports critical infrastructure needs that are not reimbursable under Medicaid and commercial insurance, such as staff salaries, individual patient education, community-level outreach, and public education about family planning, women's health, and sexual health issues. Without Title X, access to high-quality family planning services for low-income Alaskans would not be possible.

- The average cost of a Medicaid-funded birth is \$23,825.viii In 2010, births resulting from unintended pregnancies cost Alaska's taxpayers \$113.7 million.ix
- The Title X program helps alleviate the costs of unintended pregnancy through contraception, counseling, and other services.*

Title X is Essential to Improving Public Health and Saving Taxpayer Dollars in Alaska

Cutting funding for family planning services will lead to more unintended pregnancies and higher health care costs in Alaska. Family planning helps women and families plan the timing and spacing of their pregnancies, which results in better educational attainment and economic security; these, in turn, are linked to better health outcomes for women, men, and families.

- Family planning services at Alaska's Title Xfunded health centers helped prevent 1,800 unintended pregnancies in 2014, which would likely have resulted in 900 unintended births and 600 abortions.xi
- Without publicly funded family planning, the number of unintended pregnancies in Alaska would be 23% higher.xii
- Title X-funded services produce significant cost savings to the federal and state governments; services provided at Title X-

Alaska's Title X-funded health centers provide a wide range of services:

- Pregnancy testing
- Contraceptive services
- Pelvic exams
- Screening for cervical and breast cancer
- Screening for high blood pressure, anemia, and diabetes
- Screening for STDs and HIV/AIDS
- Infertility services
- Health education
- Referrals for other health and social services

supported sites in Alaska accounted for nearly \$18 million in such savings in 2010 alone.xiii

Additional cuts to Title X funding—especially in the current economy—would harm thousands of low-income and poor families throughout Alaska, in turn costing, not saving, the federal government money.
