

# Title X in Massachusetts Improving Public Health and Saving Taxpayer Dollars

Between FY2005 – FY2015, funding for Title X was cut by \$150 million — 10% in ten fiscal years.

#### Title X Served 67,293 Massachusetts Residents in 2015

The Massachusetts Department of Public Health, Action for Boston Community Development, the Planned Parenthood League of Massachusetts, Health Imperatives Inc., and Healthquarters Inc. are the Title X grantees in Massachusetts, i supporting 82 Title X-funded health centers across the state including federally qualified health centers, Planned Parenthood service sites, and private non-profits. The Title X network served 57,641 women and 9,652 men, for a total of 67,293 residents of Massachusetts in 2015.

Title X provides high-quality family planning services and other preventive health care to low-income and uninsured individuals who may otherwise lack access to health care.

- > Of the 67,293 patients served, **59%** had incomes at or below 100% of the federal poverty level (FPL), iv *meaning they earned* \$11,770 a year or less.
- Fighty-seven percent of Title X patients in Massachusetts earned less than \$29,425. ia year (250% of the FPL). iii

#### Title X Saves Massachusetts's Taxpayer Dollars

Title X supports critical infrastructure needs that are not reimbursable under Medicaid and commercial insurance, such as staff salaries, individual patient education, community-level outreach, and public education about family planning, women's health, and sexual health issues. Without Title X, access to high-quality family planning services for low-income Massachusetts residents would not be possible.

- The average cost of a Medicaid-funded birth is \$15,109. In 2010, births resulting from unintended pregnancies cost Massachusetts's taxpayers \$357.9 million.
- The Title X program helps alleviate the costs of unintended pregnancy through contraception, counseling, and other services.

### Title X is Essential to Improving Public Health and Saving Taxpayer Dollars in Massachusetts

Cutting funding for family planning services will lead to more unintended pregnancies and higher health care costs in Massachusetts. Family planning helps women and families plan the timing and spacing of their pregnancies, which results in better educational attainment and economic security; these, in turn, are linked to better health outcomes for women, men, and families.

- Family planning services at Massachusetts's Title X-funded health centers helped prevent 13,600 unintended pregnancies in 2014, which would likely have resulted in 6,600 unintended births and 4,900 abortions.xi
- Without publicly funded family planning, the number of unintended pregnancies in Massachusetts would be 25% higher.xii
- Title X-funded services produce significant cost savings to the federal and state governments; services provided at Title X-s

## Massachusetts's Title X-funded health centers provide a wide range of services:

- Pregnancy testing
- Contraceptive services
- Pelvic exams
- Screening for cervical and breast cancer
- Screening for high blood pressure, anemia, and diabetes
- Screening for STDs and HIV/AIDS
- Infertility services
- Health education
- Referrals for other health and social services

governments; services provided at Title X-supported sites in Massachusetts accounted for nearly \$140.6 million in such savings in 2010 alone.xiii

Additional cuts to Title X funding—especially in the current economy—would harm tens of thousands of low-income and poor families throughout Massachusetts, in turn costing, not saving, the federal government money.
